ChampionChip timing will be used for the race this year. Race Chip pick up will take place with packet pick up Saturday morning at 6:15 am. There will be a \$35 fee for chips that are not returned after the race. PLEASE NOTE: the Chip timing system will be based on Gun Start, not pad start. Therefore, runners must be as close to the start line as possible to obtain an accurate race time.
